

**ISSUE OF IDENTITY CARD TO RETIRED SSA OFFICERS AND
RELEASED OFFICERS WITH MINIMUM 08 YEARS OF SERVICE**

1. Refer to CGO 02/2007 and 06/2018.
2. The Competent Authority has approved issuance of "Veteran Identity Card" to Short Service Appointed Officers and released Officers (released through proper channel with approval of Competent Authority) who have completed a minimum of eight years of service.
3. The provision of issuance of "Retired Identity card" to the permanent officers who retire with pensionary benefits with a minimum service of 20 years including pension on medical grounds will continue as in vogue.
4. Indian Coast Guard Provost Marshal (ICGPM) will be the central regulating and accounting authority in this regard. These cards will be issued by Provost Marshal with prior approval of Directorate of Personnel, CGHQ. All rules and regulations enumerated in CGO 02/2007 and 06/2018 will apply in management of these Identity Cards, the same are to be handed over to the individuals on the day of retirement/release.
5. These cards will also be issued retrospectively to the SSA & released Officers of ICG who have been retired/ released from service after completion of minimum eight years on applying through Coast Guard Veteran Cell.
6. The sample of Coast Guard veteran Identity Card alongwith Application Record Card is enclosed herewith as enclosure I & II.
