WEARING OF UNIFORMS/ CIVIL ATTIRE/ MEDALS/ MINIATURES
BY ICG VETERANS

1. The wearing of Coast Guard uniform is always a matter of pride for serving Officers and Enrolled Person. The uniform, with its various insignia and decorations, is designed primarily to visually indicate the stature of those belonging to services and their ranks. Presently, only serving Officers and EPs are authorised to wear uniform as laid down in **CGO 6/93** and **CGBR Log 04**.

2. The Competent Authority has approved the wearing of Uniforms and decorations of the rank last held by retired Indian Coast Guard Officers, when attending formal/ ceremonial service functions alongwith medals/ miniatures on Formal Civil Attire, by ICG veterans. The details are as follows:-

(a) **Wearing of Uniform by Retired ICG Officers.** The retired ICG Officers may wear uniform appropriate to the occasion along with decorations of the last rank held in the service on all service functions in the manner as authorised below:-

- (i) Official parties at Rashtrapati Bhavan or Raj Bhavan.
- (ii) When invited to an official function by an Embassy, High Commission or Legation.
- (iii) At all Armed Forces functions, including ex-servicemen rallies or re-unions.
- (iv) When called upon to aid of civil power.
- (v) When visiting any service headquarters on duty.
- (vi) When calling on or meeting senior service officers and local heads of civil administration of and above the rank of Collector or Deputy Commissioner for official purposes.
- (vii) When serving on the personal staff of the President or a Governor.
- (viii) When attending a function in the honor of the National Day.

(b) **Wearing of Medals on Formal Civil Attire for ICG Veterans.** The ICG veterans may wear medals on Formal Civil Attire on functions in the manner as authorised for serving Officers and Enrolled Person on the following occasions:-

- (i) Republic Day Parade.
- (ii) Independence Day Function.
- (iii) Coast Guard Day.
- (iv) Vijay Diwas.
- (v) Wreath Laying on Memorial Day.
- (vi) Reception at Rashtrapati Bhavan and Governor's House.
- (viii) Colour Presentation Parade/ Passing out Parade.
- (ix) Re-union Functions.
- (x) Attending State or Military Funerals.
- (xi) When invited to an official function by an Embassy, High Commission or Legation.
- (xii) At all Armed Forces functions, including ex-servicemen rallies or re-unions.

(xiii) When called upon to aid of civil power.

(c) **Wearing of Miniatures on Formal Civil Attire for ICG Veterans.**

The miniatures will be worn on following occasions:-

- (i) While attending official and private functions such as Dinner, Cocktails, lunch, tea parties, and receptions etc., during day and night.
- (ii) Functions held in the messes, institutions in connection with Service Day, re-union functions.
- (iii) Functions in connection with Republic Day Parade, Independence Day Function, Colour Presentation, Reception on Passing Out Parades etc.
- (iv) When invited to an official function by an Embassy, High Commission or Legation.
- (v) At all Armed Forces functions, including ex-servicemen rallies or re-unions.

3. The attire eligible to wear medals/ miniatures by ICG Veterans are as follows:-

(a) **Formal Civil Attire for Retired Officers.**

- (i) Trouser and closed collar tunics (Jodhpuri Suit)(Blue/ Black).
- (ii) Lounge Suit.
- (iii) Coast Guard Veteran Side Cap.

(b) **Formal Civil Attire for Women Officers.**

- (i) Saree (Silk).
- (ii) Corporate Suits.
- (iii) Coast Guard Veteran Side Cap.

(c) **Formal Civil Attire for Retired Enrolled Person.**

- (i) Lounge Suit.
- (ii) Combination Suit.
- (iii) Safari Suit.


4. **Pattern of Uniform to be Worn.** The uniform shall conform to the prescribed regulations except that the pattern of the uniform and decorations should be either of the pattern at the time of their retirement or as prescribed in the latest regulations.

5. Personnel dismissed from service or discharged on disciplinary grounds are not authorised to wear uniform/ medals/ miniatures on any occasion. Uniform will not be worn at meetings of political nature.
