Conduct of 9th National Level Pollution Response Exercise (NATPOLREX-IX) off Vadinar from 23-25 Nov. 23

- In accordance with National Oil Spill Disaster Contingency Plan (NOS-DCP), Indian Coast Guard (ICG) is conducting 9th National Level Pollution Response Exercise-IX (NATPOLREX-IX) off Vadinar coast. NATPOLREX exercises the various components of the marine pollution response mechanism and evaluates preparedness of resource agencies to respond to any contingency pertaining to marine spills.
- NATPOLREX-IX is tentatively scheduled from 23-25 Nov 23 off Vadinar. 2. ICG is also extending invitation to foreign delegates as observers for the exercise. The exercise is being conducted by Coast Guard Region (North West) under the aegis of Coast Guard Commander (Western Seaboard) as follows:-

(a) Day 1: Arrival of International Observers

(a) Day 2: Table Top Exercise and Technical Session

(b) Day 3: Sea Exercise off Vadinar
