- 1. Indian Coast Guard invites applications from willing and eligible candidates for filling up following posts on deputation (ISTC) basis:-
  - (a) <u>Name of Post</u>. Principal Private Secretary (PPS) (General Central Service Group 'A', Gazetted, Ministerial) in Pay Band-3, Rs.15600-39100 plus Grade Pay of Rs. 6600/- (Revised pay in Level-11 in the pay matrix).

  - (c) **Initial period of deputation**: Initially for a period of one year

Officers of Stenographer cadre under the Central Government:-

The period of deputation (including Short-Term Contract) including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organisation/Department of the Central Government shall ordinarily not exceed three years. The officers selected will be governed by instructions contained in DoP &T OM No. 6/8/2009-Estt. (Pay II) dated 17<sup>th</sup> June, 2010 as amended from time to time. The maximum age limit for appointment by deputation (ISTC) shall be not exceeding fifty six years as on the closing date of receipt of applications.
