Applications are invited from willing and eligible candidates for filling up of post of **Sarang Lascar**(General Central Service, Group 'C', Non-Gazetted, Non-ministerial) in Pay Level 4 (Rs. 25,500 81,100/-) **on Deputation basis** in various sub-offices under Coast Guard Region (West), Mumbai. The details are as follows:-
 - (a) Vacancies: Total 06 (05 at CGDHQ-4, Kochi, 01 at CGDHQ-2, Mumbai)
 - (b) Eligibility Criteria: Person serving under the Central or State Government:
 - (i) Holding analogous posts on regular basis **OR**
 - (ii) Holding the posts carrying pay scale of (Rs. 5200-20200) with Grade pay of Rs 2400/- (Pre-revised) with six years regular service in the grade **AND**
 - (iii) Possess the educational qualification and experience as follows:-

Essential:

- (i) Matriculation pass or its equivalent from recognized boards.
- (ii) Certificate of competency as Sarang from recognized Government Institute or equivalent.

Desirable:

- (i) Two years experience as Sarang in-Charge of a vessel of twenty Horse power.
- **Note: 1.** The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Government shall ordinarily not exceed three years.
- **Note : 2.** The maximum age limit, for appointment on deputation shall be not exceeding 56 years, as on the closing date of receipt of applications.
