

**Medical Evacuations at Male by ICG Helicopter.** ICG Helo based at Maldives, undertook following MEDEVAC operations:-

(a) On 08 Jul 23, MNDF requested ICG, Maldives Dhruv Flight for MEDEVAC of a patient namely Mr. Abdulla Vishan Hassan Manik, age- 37 yrs (a Maldivian national) from Fuvahmulah to Male. The patient was diagnosed with unspecified injury of head requiring treatment by medical specialist. On receipt of the information, CG ALH took off from Gan airport at 0845 hrs and landed Fuvahmulah at 0910 hrs on 08 Jul 23. The stretcher bound patient along with one medical assistant and a relative were embarked onboard the ICG helicopter. Post embarkation, the aircraft took off from Fuvahmulah airport at 0920 h and landed Male at 1330 hrs enroute Kadhdhoo. Thereafter, the patient was handed over to MNDF authorities for further medical management at IGM Hospital, Male.



(b) On 10 Jul 23, MNDF requested ICG Maldives Dhruv Flight for MEDEVAC of a female patient namely Naila Hassan, age-36 yrs (a Maldivian national) from Kooddoo to Male. The patient was diagnosed with Heart failure, Pulmonary hypertension and severe hypoxia requiring treatment by medical specialist. On receipt of the information, CG ALH took off from Gan airport at 1030 hrs and landed Kooddoo at 1130 hrs on 08 Jul 23. The stretcher bound patient along with one medical attendant and a relative were embarked onboard the ICG helicopter. Post embarkation, the aircraft took off from Kooddoo airport at 1145 hrs and landed Male at 1605 hrs. Thereafter, the patient was handed over to MNDF authorities for further medical management at IGM Hospital, Male.



(c) On 14 Jul 23, MNDF requested ICG Maldives Dhruv Flight for MEDEVAC of a patient namely Mr. Hussain Limshad, age- 38 yrs (a Maldivian national) from Gan to Male. The patient was diagnosed with unspecified recurrent ischiorectal abscess extending into perineum K/C/O membranous nephropathy requiring treatment by medical specialist. On receipt of the information, CG ALH embarked stretcher bound patient alongwith one medical assistant and a relative and took off from Gan airport at 1110 hrs and landed Male at 1545 hrs on 14 Jul 23. Thereafter, the patient was handed over to MNDF authorities for further medical management at IGMH, Male.



(d) On 09 Aug 23, MNDF, requested ICG Maldives Dhruv Flight for MEDEVAC of a female patient namely Hawwa Abdulla, age- 62 yrs (a Maldivian national) from Gan to Male. The patient was diagnosed with Chronic ischemic heart disease requiring treatment by medical specialist. On receipt of the information, CG ALH took off from Gan airport at 1205 hrs on 09 Aug 23 alongwith the stretcher bound patient accompanied by one medical assistant and a relative embarked onboard. The aircraft landed Male at 1630 hrs enroute Kadhdhoo. Thereafter, the patient was handed over to MNDF authorities for further medical management at IGM Hospital, Male.





(e) **Medical Evacuation at Male.** On 13 Aug 23, MNDF requested ICG Maldives Dhruv Flight for MEDEVAC of a male patient namely Hassan Seed, age- 44 yrs (a Maldivian national) from Kooddoo to Male. The patient was diagnosed with Decompression sickness requiring treatment by medical specialist. On receipt of the information, CG ALH took off from Gan airport at 1615 hrs on 13 Aug 23 and landed Kooddoo at 1710 hrs. The patient on wheel chair accompanied by one medical assistant and a relative were embarked onboard. Thereafter, the patient was handed over to MNDF authorities for further medical management at IGM Hospital, Male.



(f) On 24 Aug 23, Maldives National Defence Force (MNDF), requested Indian Coast Guard (ICG) Maldives Dhruv Flight for Medical Evacuation (MEDEVAC) of a male patient namely Mohamed Nisham, age- 41 yrs (a Maldivian national) from Gan to Male. The patient was diagnosed with Acute myocardial infraction requiring treatment by medical specialist. On receipt of the information, CG Advanced Light Helicopter (ALH) took off from Gan airport at 1130 hrs on 24 Aug 23 alongwith the stretcher bound patient accompanied by one medical assistant and a relative embarked onboard. Upon landing at Male, the patient was handed over to MNDF authorities for further medical management at IGM Hospital, Male.



(g) On 08 Sep 23, Maldives National Defence Force (MNDF), requested Indian Coast Guard (ICG) Maldives Dhruv Flight for Medical Evacuation (MEDEVAC) of an infant namely Aishath Zavi Shuaib, age-08 months (Nationality Maldivian) from Gan to Male. The patient was diagnosed with acute bronchiolitis requiring treatment by medical specialist. On receipt of the information, CG Advanced Light Helicopter (ALH) took off from Gan airport at 1540 hrs on 08 Sep 23 alongwith the infant accompanied by mother and one medical assistant embarked onboard. Upon arrival at Male, the patient was handed over to MNDF authorities for further medical anagement at IGM Hospital, Male.

(h) On 10 Sep 23, Maldives National Defence Force (MNDF), requested Indian Coast Guard (ICG) Maldives Dhruv Flight for MEDEVAC of a male patient namely Ismail Hassan, age- 30 yrs (Maldivian national) from Gan to Male. The patient was iagnosed with fracture of skull and facial bones owing to RTA requiring treatment by medical specialist. On receipt of information, CG Advanced Light Helicopter (ALH) took off from Gan airport at 0845 hrs on 10 Sep 23 alongwith the stretcher bound patient accompanied by one doctor, one medical assistant and a relative. Upon arrival at Male, the patient was handed over to MNDF authorities for further medical management at IGM Hospital, Male.





(j) On 12 Sep 23, Maldives National Defence Force (MNDF), requested Indian Coast Guard (ICG) Maldives Dhruv Flight for Medical Evacuation (MEDEVAC) of a male patient namely Nasrulla Nasym, age- 63 yrs (Nationality- Maldivian) from Gan to Male. The patient was diagnosed with Non ST elevated myocardial infraction sinus bradycardia requiring treatment by medical specialist at IGM Hospital, Male, Maldives. On receipt of information, the aircraft embarked the patient accompanied by one medical assistant and a relative and got airborne at 0630 h on 13 Sep 23. The aircraft landed Male at 0915 h on 13 Sep 23 and handed over the patient to MNDF authorities for further medical management.



(k) On 22 Sep 23, Maldives National Defence Force (MNDF), requested Indian Coast Guard (ICG) Maldives Dhruv Flight for Medical Evacuation (MEDEVAC) of a male patient namely Ahmad Moosa Didi, age- 29 (Nationality- Maldivian) from Gan to Male. The patient was diagnosed with Traumatic subdural haemorrhage requiring treatment by medical specialist at IGM Hospital, Male, Maldives. On receipt of information, the aircraft embarked the patient accompanied by one medical attendant and a relative and got airborne at 1245 h on 22 Sep 23. The aircraft landed Male at 1525 h on 22 Sep 23 and handed over the patient to MNDF authorities for further medical management.



(l) On 25 Sep 23, Maldives National Defence Force (MNDF), requested Indian Coast Guard (ICG) Maldives Dhruv Flight for Medical Evacuation (MEDEVAC) of a male patient namely Mohamed Hassan, age- 34 yrs (Nationality- Maldivian) from Villigili Island to Male. The patient was diagnosed with Decompression sickness requiring treatment by medical specialist at ADK Hospital, Male, Maldives. On receipt of information, the aircraft embarked the patient accompanied by one medical assistant and a relative and got airborne from Villigilli Island at 1450 h on 25 Sep 23. The aircraft landed Male at 1700 h on 25 Sep 23 and handed over the patient to MNDF authorities for further medical management.



(m) On 25 Sep 23, Maldives National Defence Force (MNDF), requested Indian Coast Guard (ICG) Maldives Dhruv Flight for Medical Evacuation (MEDEVAC) of a male patient namely Mohamed Hassan, age- 34 yrs (Nationality- Maldivian) from Villigili Island to Male. The patient was diagnosed with Decompression sickness requiring treatment by medical specialist at ADK Hospital, Male, Maldives. On receipt of information, the aircraft embarked the patient accompanied by one medical assistant and a relative and got airborne from Villigilli Island at 1450 h on 25 Sep 23. The aircraft landed Male at 1700 h on 25 Sep 23 and handed over the patient to MNDF authorities for further medical management.
