Indian Coast Guard, having its Head Office at Headquarters of Indian Coast Guard, New Delhi -110001 (hereinafter referred to as the "Indian Coast Guard") which expression shall, wherever the context so admits, mean and include its successors in office and permitted assigns of the OTHER PART through Deputy Inspector General Kajal Roy, TM, Principal Director (Administration), Indian Coast Guard.

The Company and Indian Coast Guard hereinafter are referred individually as 'party' and collectively as 'parties'.

WHEREAS the Company is carrying on the business of financial products.

AND WHEREAS the Indian Coast Guard approached the Company to offer its 'Credit Cards' for the use by the personnel and veterans of Indian Coast Guard at special Terms & Conditions.

Product Offered by the Company

II. The Company has agreed to provide Credit Cards at special Terms & Conditions. The trade name / product name of its products, its logo / brand shall remain the property of the Company subject to applicability of various relevant laws in force.

User Support

 Company will provide brief summary of the Credit Cards for reference of the personnel and veterans of Indian Coast Guard.

 Company will provide a web form to enable the personnel and veterans of Indian Coast Guard to request for buying & support.

6. Indian Coast Guard Co-operation

i) Products Awareness:

Indian Coast Guardshall communicate to its personnel and veterans about the Company's offer for the Credit Cards at special Terms & Conditions and its utility and benefits including support available;

ii) Authentication of personnel and veterans of Indian Coast Guard:

Indian Coast Guard to help Company to check the genuineness of the personnel and veterans of Indian Coast Guard. The genuineness would be checked on the basis of employee code/veteran code and other relevant information/data in possession of the Indian Coast Guard.

7. Commitments from Company

 Company commits to provide Credit Cards at special Terms & Conditions in good working condition that are up to industry standards.

ii.Company shall build necessary infrastructure and pool of human resources to support the activities mentioned in this MOU

8. Liability

Indian Coast Guardshall not be liable for any claim of personal loss arising out of executing the arrangement mentioned in this MOU. Indian Coast Guardshall not be liable for any dispute between the personnel /veterans and the Company.

9. Duration of MOU

The duration of this MOU shall be for a period of 3 years from the date of signing of MOU. However, the benefit to Card Holder under this MOU will continue till the validity of the Card. Renewal of this MOU will be subject to mutual understanding of both Parties.

10. Confidentiality, Intellectual property rights and use of name and logo

- 10.1 Each Party shall undertake to observe the confidentiality and secrecy of documents, information and other data received from or given to the other Party during the period of the implementation of this Memorandum of Understanding or any other agreements made pursuant thereto.
- 10.2 The protection of intellectual property rights shall be enforced in conformity with the laws, rules and regulations in force from time to time.
- 10.3 Each party may use the name, logo and/or official emblem of the other party for the purposes of this MoU with the prior written approval of other Party.

11. Modification

If both the parties find any ambiguity in any of the clauses of this MOU and need clarification then both the parties shall mutually agree for the clarification required. In such case, a supplementary MOU may be signed by both the parties. Both the parties may mutually discuss and add/amend/extend the scope of this MOU from time to time.

12. Termination

Either party may terminate this MOU by serving to the other party a written notice of 60 days by assigning reasons for the same

13. Dispute Resolution


Any difference or dispute between the Parties concerning the interpretation and/or implementation and/or application of any of the provisions of this Memorandum of Understanding shall be settled amicably through mutual consultation and/or negotiation between the Parties.

Further, in absence of any resolution of dispute, controversy or claims arising out of or relating to this MOU, its validity, breach or termination thereof, shall be settled by arbitration in accordance with the provisions of the Indian Arbitration and Conciliation Act. 1996 by

Sole arbitrator appointed mutually by both the parties. The place of arbitration shall be at Mumbai. The arbitral procedure shall be conducted in the English and any award or awards shall be rendered in English. The procedural law of the arbitration shall be the Indian law. The obligations of the Parties under or pursuant to this Clause, including the arbitration agreement in this Clause, shall be under the exclusive jurisdiction of the courts located at Delhi only.

14. Indemnity

Either Party agrees to indemnify and keep indemnified, save harmless and defend each other from and against any loss, damage, claim, action, proceedings, costs, charges and expenses that may be suffered or incurred to them on account of any
