- 4. <u>Location of the Tender Box</u>: Tender Box kept in the Palashpalli Office, CGAE, Bhubaneswar, Marked 'Tender Box'. Bids dropped into the wrong tender box will be rendered invalid.
- 5. <u>Place of opening of the Bids</u>: Bids will be opened at Coast Guard Air Enclave Bhubaneswar The Bidders may depute their representatives, duly in writing, to attend the opening of Bids on the due date and time. Rates and important commercial/technical clauses quoted by all bidders will be read out in the presence of the representatives of all the bidders. - 6. **Forwarding of Bid :** Bids should be forwarded by Bidders under their original memo / letter pad inter alia furnishing mandatory details like TIN number, CST/GST number.
- 7. <u>Clarification regarding contents of the RFP</u>: A prospective bidder who requires clarification regarding the contents of the bidding documents shall notify to the Buyer in writing about the clarifications sought not later than 14 (fourteen) days prior to the date of opening of the Bids. ### PART III - STANDARD CONDITIONS OF RFP

The Bidder is required to give confirmation of their acceptance of the standard conditions of the Request for Proposal mentioned below which will automatically be considered as part of the Contract concluded with the successful Bidder (i.e. Trader in the contract) as selected by the Buyer. Failure to do so may result in rejection of the Bid submitted by the Bidder.

- 1. <u>Law</u>: The contract shall be considered and made in accordance with the laws of the Republic of India. The contract shall be governed by and interpreted in accordance with the laws of the Republic of India.
- 2. <u>Effective Date of the Contract</u>: The contract shall come into effect on the date of signatures of both the parties on the contract (Effective Date) and shall remain valid until the completion of the obligations of the parties under the contract. The deliveries and supplies and performance of the services shall commence from the effective date of the contract.
- 3. <u>Arbitration</u>: All disputes or differences arising out of or in connection with the contracts shall be settled by bilateral discussions. Any dispute, disagreement or question arising out of or relating to the contract or relating to the construction or performance which cannot be settled amicably, may be resolved through arbitration. The standard clause of arbitration is as per Forms DPM-7, DPM 8 and DPM 9 (Available in MoD website and can be provided on request).
- 4. <u>Liquidated Damages</u>: In the event of the trader's failure to supply the storage / goods and conduct trials, installation of equipment, training, etc as specified in this contract, the Buyer may, at his discretion, withhold any payment until the completion of the contract. The BUYER

may also deduct from the TRADER as agreed, liquidated damages to the sum of 0.5% of the contract price of the delayed / undelivered stores / services mentioned above for every week of delay or part of a week, subject to the maximum value of the Liquidated Damages being not higher than 10% of the value of delayed stores.

- 5. <u>Termination of Contract</u>: Termination of Contract: The Buyer shall have the right to terminate this Contract in part or in full in any of the following cases:-
  - (a) The delivery of the material is delayed for causes not attributable to Force Majeure for more than (02 months) after the scheduled date of delivery.
  - (b) The Seller is declared bankrupt or becomes insolvent.
  - (c) The delivery of material is delayed due to causes of Force Majeure by more than (01months) provided Force Majeure clause is included in contract.
  - (d) The Buyer has noticed that the Seller has utilised the services of any Indian/Foreign agent in getting this contract and paid any commission to such individual/company etc.
  - (e) As per decision of the Arbitration Tribunal.

# 6. Taxes and Duties

- i) <u>General:1</u>. If Bidder desires to ask for excise duty or Sales Tax /GST extra, the same must be specifically stated. In the absence of any such stipulation, it will be presumed that the prices include all such charges and no claim for the same will be entertained.
- ii) <u>Customs Duty</u>: <u>Custom duty exemption certificate will be issued</u> on request for imported stores offered against forward delivery, the bidder shall quote prices thereof exclusive of customs duty.
- iii) Excise Duty: Excise Duty exemption certificate will be issued on request where the excise duty is payable on advalorem basis, the bidder should submit along with the tender, the relevant form and the Manufacturer's price list showing the actual assessable value of the stores as approved by the Excise authority.
- iv) <u>Sales Tax /GST</u>: If it is desired by the Bidder to ask for Sales tax /GST to be paid as extra, the same must be specifically stated.
- v) Octroi Duty & Local Taxes: Octroi Duty and Local Taxes Exemption certificate will be issued on request. Normally materials to be supplied to Government department contracts are exempted from levy of town duty, Terminal Tax and other levies of Local Bodies.

While awarding the contract, the quantity ordered can be increased or decreased by the Buyer within this tolerance limit.
- 3. Payment Terms for Indigenous Sellers It will be mandatory for the Bidders to indicate their bank account numbers and other relevant epayment details so that payments could be made through ECS/EFT. 100% payment will be made on delivery of items after inspection of items.
- 4. Advance payments: No advance payments will be made.
- 5. Paying Authority: Controller of Defence Accounts (Navy), Kolkata
- 6. Force Majeure clause
  - (a) Neither party shall bear responsibility for the complete or partial nonperformance of any of its obligations (except for failure to pay any sum which has become due on account of receipt of goods under the provisions of the present contract), if the non-performance results from such Force Majeure circumstances as Flood, Fire, Earth Quake and other acts of God as well as War, Military operation, blockade, Acts or Actions of State Authorities or any other circumstances beyond the parties control that have arisen after the conclusion of the present contract.
  - (b) In such circumstances the time stipulated for the performance of an obligation under the present contract is extended correspondingly for the period of time of action of these circumstances and their consequences.
