## DRAFT RRs FOR THE POST OF DRAUGHTSMAN (GROUP 'C' POST)

## NOTIFICATION

- S.R.O. In exercise of the powers conferred by the proviso to Article 309 of the Constitution and in supersession of the Coast Guard Organisation Draughtsman Grade III Recruitment Rules, 2001 in so far as these relate to the said post except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the posts of Draughtsman in Coast Guard Organisation under the Ministry of Defence namely:-
- 1. Short title and commencement. (1) These rules may be called the Ministry of Defence, Coast Guard Organisation Draughtsman Recruitment Rules, 2019.
  - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. **Initial Constitution**. The incumbent of the post "Draughtsman Grade III" in the Coast Guard Organisation at the commencement of these rules shall be redesignated as Draughtsman.
- 3. Number of post, classification and level in the pay matrix. The number of the said posts, their classification and level in the pay matrix attached thereto shall be specified in columns (2) to (4) of the said Schedule annexed to these Rules.
- 4. **Method of recruitment, age limit, and qualifications, etc.** The method of recruitment, age limit, qualifications and other matters relating to the said posts shall be as specified in columns (5) to (13) of the said Schedule.
- 5. Disqualification. No person,-
- (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to any of the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

6. **Power to relax**.- Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

7. **Saving**. Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Other Backward Classes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
