**RECRUITMENT OF CHARGEMAN, DRAUGHTSMAN, MT FITTER (MECH) AND  
MTS (PEON) FOR THE VACANCY YEAR 2022**

1. Indian Coast Guard had invited applications for six posts of Chargeman (01-EWS & 01 ST), Draughtsman (01 UR), MT Fitter (Mech) (01 UR) and MTS (Peon) (01 ST & 01 EWS) vide the advertisement published in Employment Newspaper and ICG website on 17 Sep 22. The written examination for the said posts was conducted on 07 Feb 23.
2. The maximum marks for the written examination was 80. The passing marks for various categories are as follows:-
  - (a) UR/EWS/OBC : 40 (50% of total marks)
  - (b) SC/ST : 36 (45% of total marks)
3. The list of all the candidates appeared in written examination alongwith their marks is placed at **Enclosure-I**.
4. On the basis of marks obtained and category wise vacancies available, **04** candidates have been selected as per merit for appointment to the said posts. No candidate is qualified for the post of MT Fitter (Mech) and no ST candidate is qualified for the post of MTS (Peon). The list of selected candidates as per merit is placed at **Enclosure-II**.
5. The appointment of stand by candidate will be subject to non-reporting/ non-joining of candidates to the said post in accordance with the vacancies and merit list as published within the stipulated time period of filling up of said vacancy.
6. A Memorandum having terms of appointment is being sent by registered/speed post to the 04 selected candidates as per Enclosure-II. The selected candidates have to forward their acceptance certificate enclosed with the Memorandum within one month from the date of receipt of the Memorandum on the E-mail ID mentioned in the Memorandum.
