3. **Important Instructions to Candidates:-**

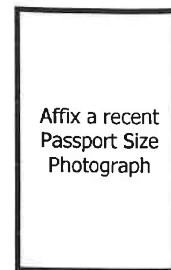


