**RECRUITMENT OF GROUP 'C' CIVILIAN POSTS FOR THE
VACANCY YEAR 2023 & 2024**

1. Headquarters, Coast Guard Region (East), Chennai had invited applications for the following Group 'C', Non-Gazetted posts vide the advertisement published in Employment News and ICG website on 05 Aug 23. The written examinations for the said posts were conducted from 03 Jan 24 to 05 Jan 24: -

2. The maximum marks for the written examination was 80. The passing marks for various categories are as follows: -

- (a) UR/EWS/OBC : 40 (50% of total marks)
(b) SC/ST : 36 (45% of total marks)

3. The list of all the candidates who have attended the written examination for the said posts alongwith their marks is placed at **Enclosure-I**.

4. On the basis of marks obtained and category wise vacancies available, **10 Candidates** have been selected as per merit for appointment to the said posts. The list of selected candidates as per merit is placed at **Enclosure-II**.

5. The appointment of standby candidate will be subject to non-reporting/ non-joining of candidates to the said posts in accordance with the vacancies and merit list as published within the stipulated time period of filling up of said vacancy.
6. A Memorandum having terms of appointment is being sent by registered/speed post to 10 selected candidates as per **Enclosure-II**. The selected candidates have to forward their acceptance certificate as per format enclosed with the Memorandum within one month from the date of receipt of the Memorandum by E-mail (ID mentioned in the Memorandum).
7. Provisional appointment will be issued to the selected candidates on receipt of the documents specified in the Memorandum. Appointment in ICG is provisional and subject to satisfactory verification of credentials / documents of the candidate.
