INTRODUCTION

1. The Indian Coast Guard (ICG) was established through the Coast Guard Act, 1978 with the motto “वयम् रक्षामः” (Vayam Rakshamah) translating from Sanskrit as “We Protect”. The mission of the ICG encompasses ensuring Safety, Security, and Law Enforcement at sea, providing Search and Rescue services, and Protecting the Marine Environment.
2. In Jun 24, post formation of new government at the Centre, Hon’ble Raksha Rajya Mantri Shri Sanjay Seth, visited Indian Coast Guard Headquarters, New Delhi. During the visit, DG Rakesh Pal, AVSM, PTM, TM, DGICG provided insight on the charter of duties and capabilities of Indian Coast Guard. Hon’ble Minister expressed his appreciation for dedicated efforts and commitment of ICG personnel in ensuring safety and security of India’s coastal and marine domain.
3. During International Yoga Day-2024, in the spirit of promoting wellness, Indian Coast Guard celebrated the Day of Yoga with great enthusiasm at every level. The event underscored the importance of physical and mental well-being through the practice of yoga.
4. In the month of Jun 24, the operational tempo has been continued with special focus on maritime safety being start of monsoon season, as several incidents of grounding, stranding, and drifting of vessels have been observed in the past. To ensure safety and security of fishermen, and merchant marine, special CIPs and regular advisories have also been issued.
5. The details of ICG operational activities undertaken since last monthly report are enumerated in this report.

MAJOR OPERATIONS

A. Seizure of 14 Kgs Sea Cucumbers (Prohibited Species).

On 27 May 24, based on input, ICG team apprehended a fishing boat alongwith 07 crew and seized 14 Kgs raw Sea Cucumber worth ₹ 6.20 Lakhs off Manaikkadu, Tamil Nadu. The seized sea cucumber was handed over to Forest department for further disposal.

COOPERATION WITH FOREIGN MARITIME AGENCIES

A. Visit of ICG Women officers to Colombo, Sri Lanka

Heads of Asian Coast Guard Agencies Meeting (HACGAM) is a global forum which has 23 member countries (including India). High Level Meeting (HLM) of 20th HACGAM is scheduled in Sep 24 in South Korea. As a prelude to the 20th HACGAM, Working Level Meeting was conducted from 17-20 Jun 24 at Incheon, South Korea. One ICG officer participated in the event. Presently, ICG is chairing the Working Group of Search and Rescue. The coordination, collaboration & sharing of best practices for safe & secure seas were highlights of the meeting.

B. Surveillance by CSN.

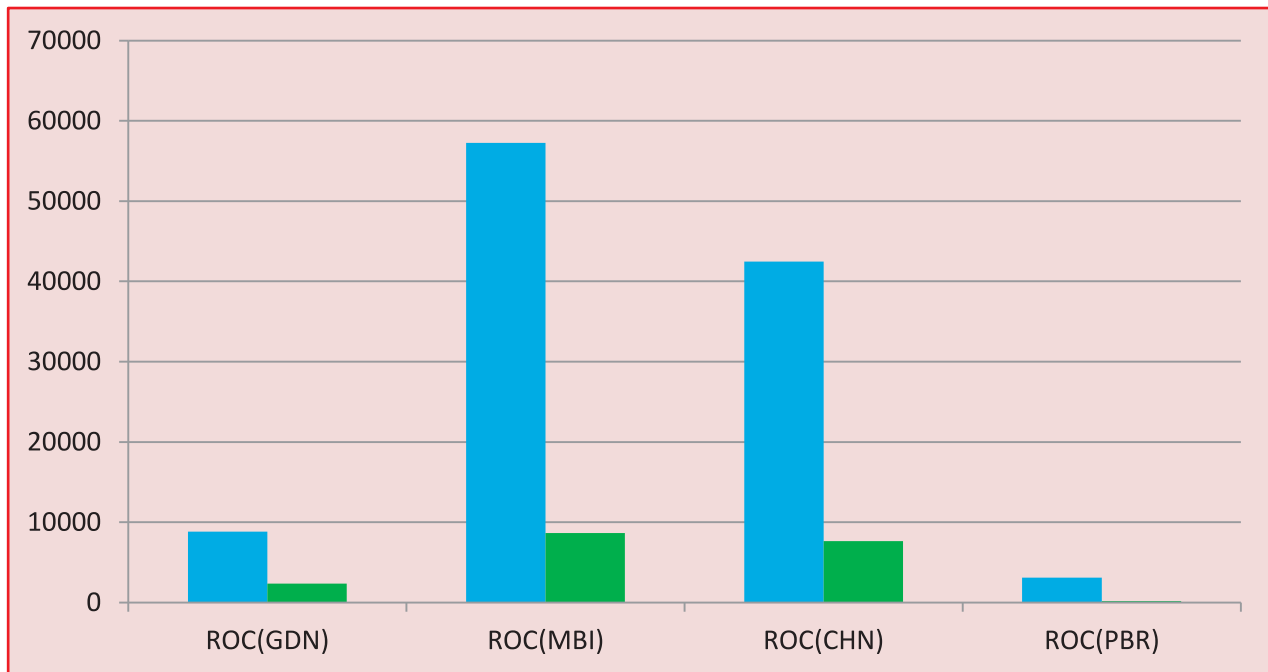


Fig-1 : Radar & AIS Contacts Monitored at Remote Operating Centers

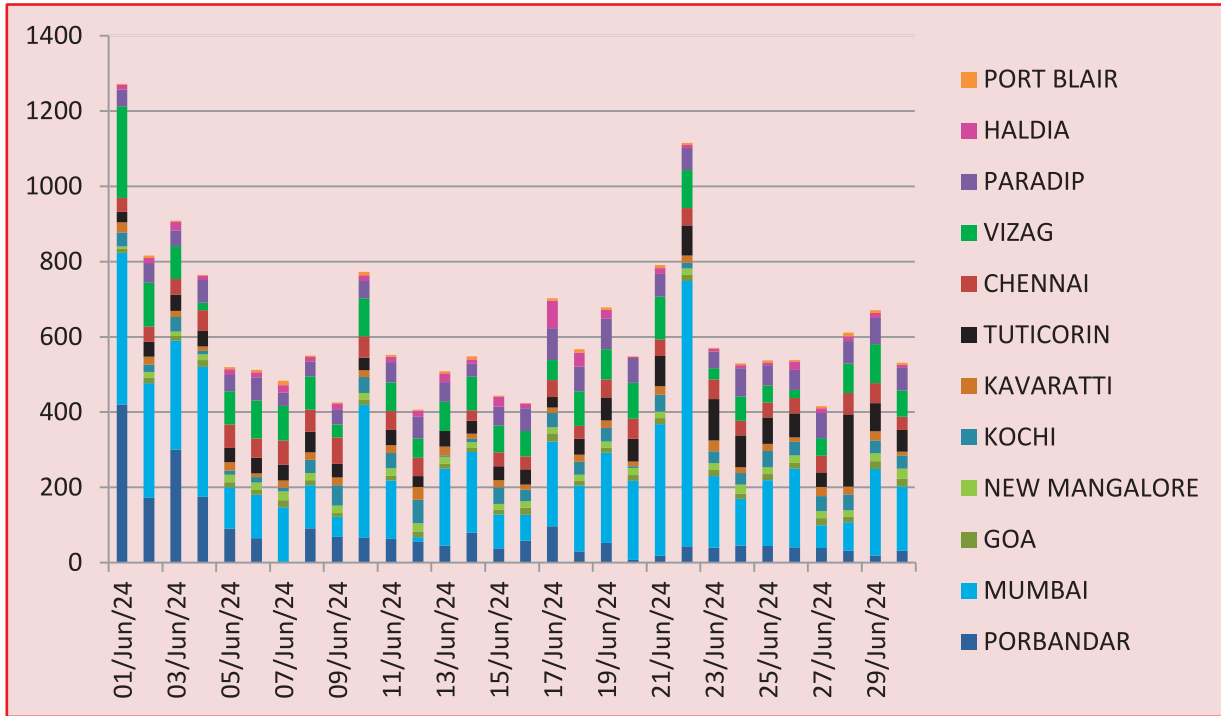


Fig-2: AIS Tracks Monitored at Remote Operating Stations

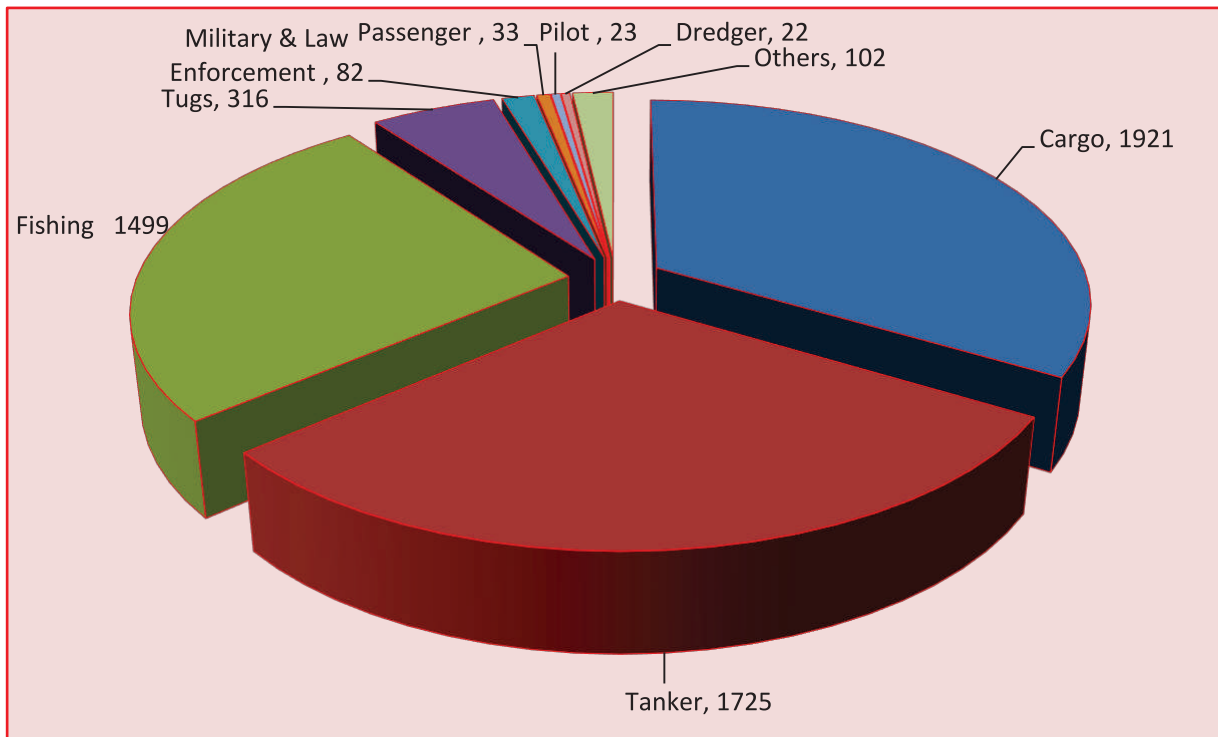


Fig-3 : Type of Vessels

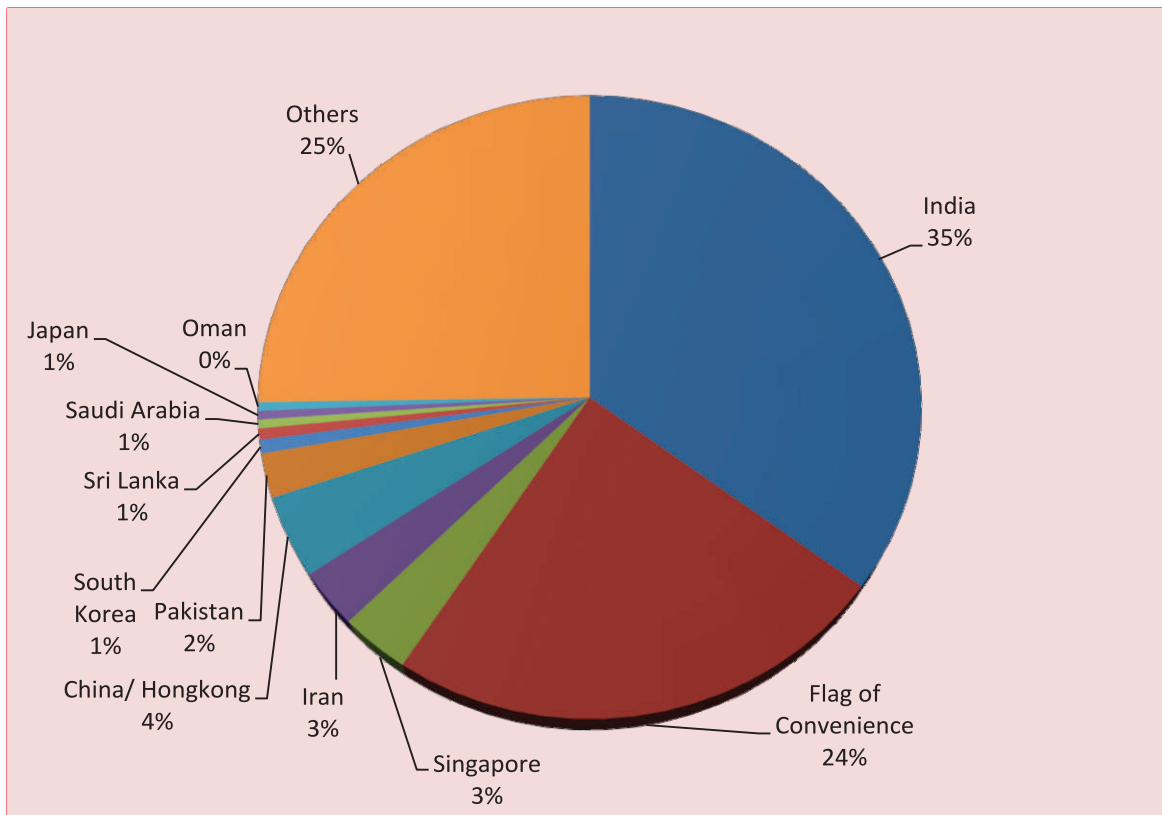


Fig-4 : Flags of Vessels

C. Fishing Activities in Northern Indian Ocean –Jun 24.

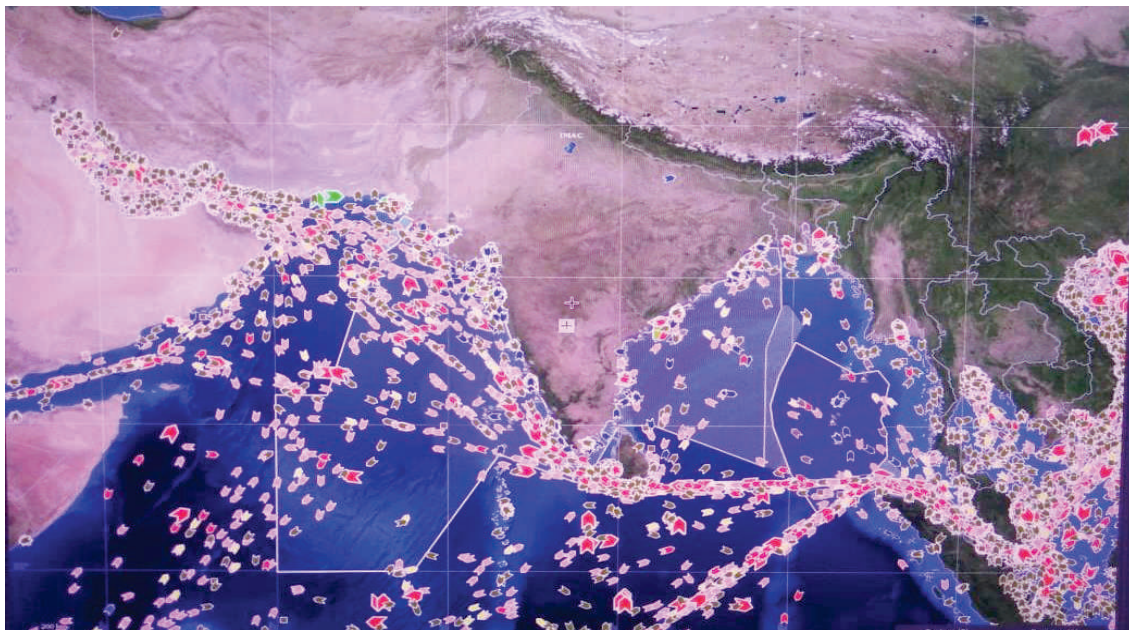


Figure 1 Maritime Traffic in Northern Indian Ocean

COASTAL SECURITY/ SURVEILLANCE

A total of 228 Fishing Vessels (FVs) were observed transmitting on AIS in Northern Indian Ocean in the month of Jun 24. The analysis of fishing activities is based on kinematics such as low speed. The data towards numbers of FVs have been garnered from AIS transmission. However, the actual numbers of FVs may be higher than the reported data as many FVs may not be transmitting on AIS. The area wise analysis of FVs operating in Bay of Bengal & Arabian Sea (beyond EEZ) and Indian EEZ for the month of Jun 24 is as follows: -

(i) Arabian Sea (Beyond EEZ).

A total of 09 FVs were observed transmitting on AIS and appreciated to be engaged in fishing. Out of these, numbers of Chinese, Sri Lankan, Iranian and Taiwanese FVs are 01, 05, 02 and 01 respectively. No FV of India and Pakistan was observed transmitting on AIS during the period. Majority of FVs withdrew from area by end of May 24 which may be due to onset of Monsoon or voluntary fishing moratorium declared by flag state.

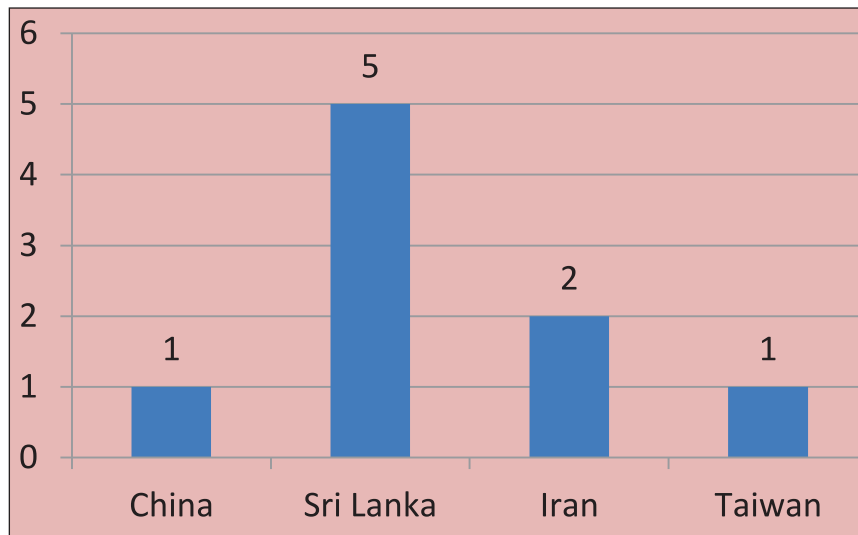


Figure 2 Flag-wise Fishing Vessels: Arabian Sea

(ii) Indian EEZ.

A total of 219 Indian flagged FVs were observed transmitting on AIS. Majority of FVs were observed operating on west coast of India prior to fishing ban period. However, fishing activities were also observed on east coast post fishing ban period. Govt of India imposed fishing ban on east coast and west coast for 61 days w.e.f. 15 Apr 24 and 01 Jun 24 respectively. No foreign FV was observed engaged in fishing in Indian waters.

(iii) Bay of Bengal (Beyond EEZ).

No fishing activities was observed in high seas in Bay of Bengal which may be due to onset of Monsoon.

A. Pollution Response Seminar/ Workshop at ICGS Murud Janjira.

A two-day Seminar cum Workshop on Pollution Response Seminar/Workshop was conducted at ICGS Murud Janjira from 05-06 Jun 24. The aim of the seminar was to validate the SOPs of all resource agencies and stakeholders in Oil spill response capabilities. 20 participants from the various ports/ oil handling agencies including ICG officers and SOs/ EPs participated in the seminar.

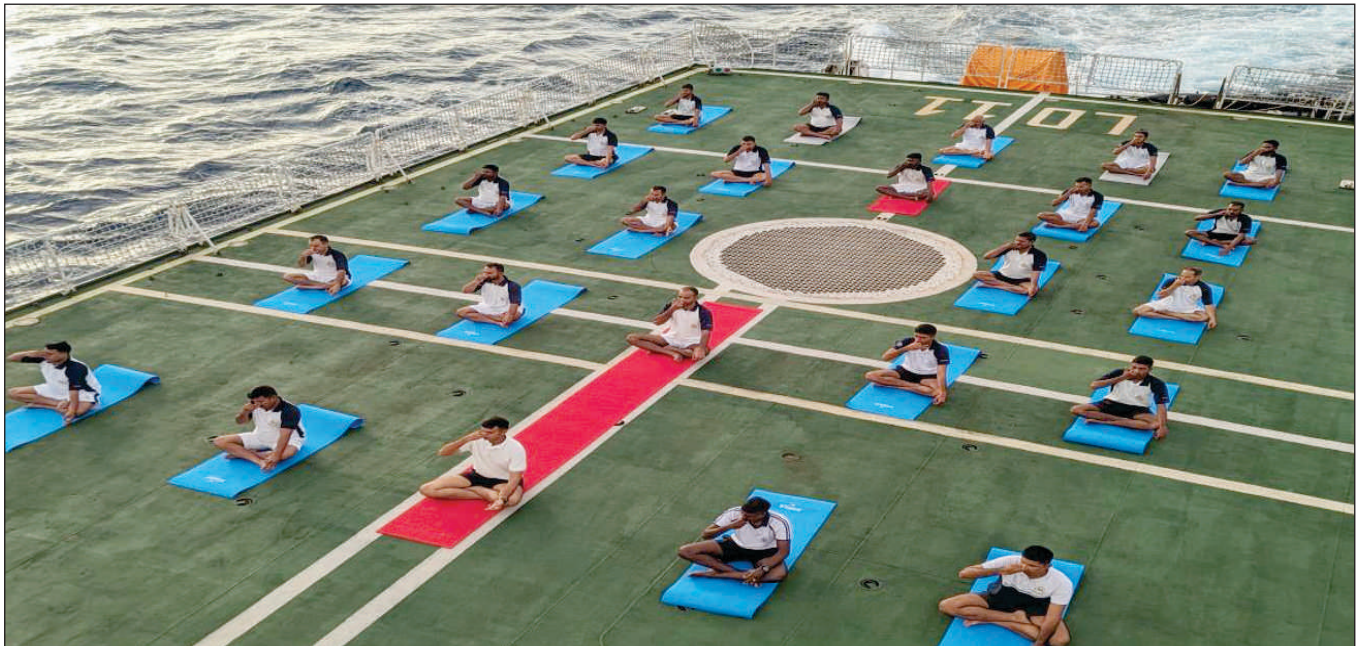

operational efficiency. The NGOPVs, designed to meet the evolving challenges of maritime security, are equipped with state-of-the-art machinery and equipment. Powered by two diesel engines, these vessels are capable of achieving a maximum continuous speed of 23 knots and covering a distance of up to 5,000 nautical miles. Furthermore, they boast integral twin-engine helicopter facilities and staging for heavy helicopters, enabling swift and effective aerial surveillance and response capabilities.
