MEMORANDUM OF UNDERSTANDING

THE FIRST PARTY represented herein by the Indian Coast Guard, National Stadium India Gate, New Delhi and Cavalier Coaching and security network pvt ltd, the second party represented herein by its Director, Maj Sunil Chopra (Retd)

PURPOSE OF MOU

In particular, this MOU is intended to provide following benefits and information to the serving personnel and wards of Indian Coast Guards serving and retired personnel.

1. To provide coaching classes for SSB INTERVIEW and Written exam for NDA / CDA / OTA / AFCAT / CAPF / ICG (COMBINED CGCAT) on concessional rate
2. Organize Seminars / Workshops on Career in Defence services on required basis and as mutually agreed between the two parties.
3. Provide Information and Assistance in filling applications for various defence related entries, to candidates / students contacting second party through or with reference of the first party.

● NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

Clause 1

CO-OPERATION

1.1 Both parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective Operations. The parties shall keep each other informed of potential opportunities and share all information that may be relevant to secure additional opportunities for one another.

1.2 The co-operation between First Party and Second Party will facilitate effective utilization of the vast experience and capabilities of the Second Party in providing Education related services in the field of career in defence and CAPF keeping in mind the needs of the First Party.

1.3 Both parties shall nominate a contact person / appointment for smooth and effective communication for furtherance of the common objectives.

Clause 2

SCOPE OF THE MOU

2.1 Both parties believe that close co-operation between the two would be for major benefit of the student community of the Indian Coast Guard fraternity in preparing for competitive exams to join Defence / CAPF.

2.2 The Second Party will give 25% concession on the existing tuition fees to the students of First Party for providing SSB Interview and written coaching in the premises of Second Party.

2.3 The Second Party will provide coaching to the students of the First Party for SSB INTERVIEW and Written exam for / NDA / CDA / OTA / AFCAT / CAPF / ICG (COMBINED CGCAT) at Second Parties premises located in New Delhi.

2.4 The Second Party if required will also provide boarding & lodging facility to the students of the First Party on the prevailing rates at the time of admissions.


Clause 3
