Dear Shri Pal Sir,

I take liberty to introduce myself and submit a proposal for welfare of the wards of Coast Guard Personnel. I joined BSF in 1976 as AC and superannuated in 2011 in the rank of IG/CLO after rendering 35 years group 'A' service. I joined this Institution in 2011 as Dean (Academic) and Chief Proctor with some other roles and responsibilities. It has been my endeavour to help the Coast Guard personnel who work under difficult conditions and are not able to take care of the education of their children due to deployment in far flung areas.

In token of recognition to the Yeoman Service of Coast Guard Personnel to safeguard the territorial integrity and National Sovereignty, the Management of RKG Group of Institutions has decided to grant 30% concession in tuition fee in all courses viz: **B.Tech, M.Tech (ECE), B.Pharma, M. Pharma, D.Pharma, MBA, MCA, BBA & BCA**. Further, to reduce financial burden on the Coast Guard personnel, fee can be deposited in two installments. The Management has also introduced some financial incentives for meritorious students as well as the branch specific students.





The students living in hostels will be provided the Group Medical Insurance Cover of Rs. 2.5 lakh and also an Accidental Insurance cover of Rs. 2 lakh for which an amount of Rs. 2000/- will be charged extra.

The hostel fee may be deposited through College ERP (<https://cimsstudent.mastersofterp.in/>) from 1st May, 2023 to 31st July, 2023 (In case of 1st year fee can be deposited upto 31.08.2023). The steps to be taken for using ERP are mentioned below:

Annexure – II

Eligibility Criteria for various Courses

• **FOR ADMISSION TO FIRST YEAR B.Tech.**

B.Tech is a four year degree course. For admission to first year of B.Tech a candidate must have passed intermediate examination of U.P. Board or 10 + 2 level examination or its equivalent from any recognized board / University with minimum aggregate marks of 45% for General & OBC and 40% for SC / ST category in the Subject group (Physics, Chemistry & Mathematics) without grace marks.

• **FOR ADMISSION TO FIRST YEAR B.PHARMA**

B.Pharm is a four year degree course . For admission to first year of B.Pharm a candidate must have clearly passed intermediate examination of U.P. Board or 10+2 level examination or its equivalent from any recognized Board / University with Physics, Chemistry, and Mathematics/Biology securing minimum 45% marks (40% marks for SC/ST Category) in aggregate in required three subjects.

• **FOR ADMISSION TO SECOND YEAR (LATERAL ENTRY) OF B. Tech**

A candidate who has passed 3 years Diploma in Engineering course securing minimum 45% marks for General & OBC and 40% marks for SC / ST category in aggregate or 3 years B.Sc. degree plus having passed 10+2 exam with Mathematics as one subject, securing minimum aggregate marks 45% for General & OBC and 40% for SC / ST in B.Sc.

• **FOR ADMISSION TO SECOND YEAR (LATERAL ENTRY) OF B. PHARMA**

A Candidate who has passed 2 years Diploma in Pharmacy approved by the Pharmacy Council of India (PCI) with minimum 45% marks (40% for SC/ST) recognized by the Board of Technical Education, U.P. is eligible for admission to second year of B. Pharm.

• **FOR ADMISSION TO FIRST YEAR M.Tech (ECE) (Post Graduate Course)**

M.Tech (ECE) is a two year course. For admission to first year of M.Tech (ECE) a candidate should be B.Tech qualified in a related stream.

• **FOR ADMISSION TO FIRST YEAR M.PHARM (Post Graduate Course)**

M.Pharm is a two year PG course (full time). For admission to first year of M.Pharm a candidate should have B.Pharm degree from a PCI approved Institute and should have scored atleast 60% marks in B.Pharm.

• **FOR ADMISSION TO FIRST YEAR MBA (Post Graduate Course)**

MBA is a two year PG course. For admission to first year of MBA a candidate must have passed bachelors degree of minimum three years duration from any recognized University of India, passing clearly without grace marks with an aggregate of minimum 50% marks for General & OBC and 45% marks for SC / ST Category. Also the candidates who are waiting for their final year graduation result can also apply for MBA programme but their candidature will be subject to clearing the qualifying examination as per the above mentioned eligibility criteria.

• **FOR ADMISSION TO FIRST YEAR MCA (Post Graduation Course)**

MCA is a two year PG course. For admission to first year of MCA a candidate must have passed Bachelors degree course of 3 years minimum duration from any recognized University; or its equivalent, securing minimum 50% (45% for SC/ST) marks in aggregate. Candidate must have passed Mathematics at 10+2 level or Graduation level.

• **FOR ADMISSION TO FIRST YEAR BBA**

BBA is a three year course. For admission to first year of BBA a candidate should have passed 10+2 (or its equivalent) examination with 45% marks for General and OBC and 40% marks for SC/ST from a recognized Board/ University. Also, the students who appeared in 10+2 examinations and are awaiting their result, are also eligible to apply but their candidature will be subject to clearing the qualifying examination.

• **FOR ADMISSION TO FIRST YEAR D.Pharm**

D.Pharm is a two year Course. For admission to 1st year of D.Pharm a candidate should have passed 10+2 examination with Physics, Chemistry and Biology or Mathematics from any recognized board / University; or Any other qualification approved by the Pharmacy Council of India (PCI) as equivalent to the above examination.

• **FOR ADMISSION TO FIRST YEAR BCA**

BCA is a three year course. For admission to first year of BCA a candidate should have passed 10+2 (or its equivalent) examination with 45%marks for General/ OBC and 33% marks for SC/ST. Maths mandatory at High School Or Intermediate level.


